## **COVID-19, Illness and Allergy Considerations**

#### ACKNOWLEDGMENT AND DISCLOSURE

#### Parent/Guardian:

Please read and agree to the following as it pertains to changes, we have made in our policy and procedures in response to the COVID-19, influenza and other communicable illnesses.

- I understand that no unnecessary personal items shall be brought to school by my child e.g.
  toys, backpacks, etc. All children are required to bring their provided tote bags only to
  school daily apart from kindergarten students attending the LLAMAS enrichment
  program.
- 2. I understand that to enter upon the facility premises my child must be free from COVID19 symptoms. If, during the day, any of the following symptoms appear my child will be brought to the office, and I will be contacted. My child must be picked up from the facility within 30 minutes of being notified.

Symptoms include,

- Fever of 100.4 degrees Fahrenheit or higher
- Dry cough
- Shortness of Breath
- Chills
- Loss of taste or smell
- Sore Throat
- Muscle aches
- Vomiting

While we understand that many of these symptoms can also be associated to non-COVID-19 related issues we must proceed with an abundance of caution. These symptoms typically appear 2-7 days after being infected so please take them seriously. Your child will need to be symptom free *without any medications* for 48 hours before returning to the facility.

- 3. I understand that fever reducers will not be given to my child on any day of attendance, regardless of reason.
- 4. I understand that my child's temperature may be taken via digital thermometer while on facility premises if the student exhibits symptoms.
- 5. Masking is optional.

- 6. I understand that my child will be required to wash their hands using CDC recommended handwashing procedures throughout the day using soap and water and rubbing for at least 20 seconds.
- 7. I understand that if my child attends full day, All lunch containers and Bento boxes, will be labeled with my child's name. Water bottles are also allowed but will be sent home daily to be washed and sanitized. Please check food labels very thoroughly. All items must be peanut and tree nut free including products that are manufactured in a facility that processes peanuts. This will ensure the safety of all students. Any items in question will be sent home with a note provided by the Lunch Bunch staff.
- 8. I understand that while present in the facility each day my child will be in contact with children, families and other employees who are also at risk of community exposure. I understand that no list of restrictions, guidelines or practices will remove 100% of the risk of exposure to COVID-19 or other illnesses viruses can be transmitted by persons who are asymptomatic and before some people show signs of infection. I understand that I play a crucial role in keeping everyone in the facility safe and reducing the risk of exposure.
- 9. I understand that if cases of any virus or illness are widespread in a specific classroom or throughout the school, that NLA as a private entity reserves the right to cancel classes for deep cleaning without tuition reimbursement unless said cancellation exceeds 10 school days.
- 10. I understand that this situation is fluid, and these policies and procedures are subject to revision.
